



DECLARATION OF REACH & RoHS COMPLIANCE AEROSPACE LUBRICANTS, INC.

July 16, 2019

This letter serves to document REACH and RoHS compliance for all products that Aerospace Lubricants, Inc. manufactures and distributes.

REACH Compliance

All products manufactured and distributed by Aerospace Lubricants, Inc. **comply** with the requirements outlined in European REACH regulations (**Regulation (EC) No 1907/2006, as amended by (EC) No 1272/2008**)

- All products manufactured by Aerospace Lubricants, Inc. are mixtures which have been manufactured within the United States, and therefore have not required registration.
Note - Importers into the EU may still be required to follow REACH registration requirements.
- No chemical on the **July 16, 2019 Candidate List of Substances of Very High Concern (SVHC)** has been used in the manufacture of any product from Aerospace Lubricants, Inc. above a concentration of 0.1%.
Note – a few products contain chemicals from the SVHC list in trace amounts, well below the required reporting limit of 0.1%.
- No chemical on the **June 24, 2019 List of Substances Restricted under REACH (Annex XVII)** has been used above any applicable restricted concentration.
Note – a few products contain chemicals listed in Annex XVII in trace amounts. In all cases, the applications for our products are not affected by the given restriction. Furthermore, the restricted chemicals are present at trace concentrations well below the limits specified in the restriction.
- No chemical on the **Authorization List (Annex XIV), as of July 16, 2019**, is used in the manufacture of any products from Aerospace Lubricants, Inc., with the exception of Tribolube® Scuba Conditioner.
Note – Specific information on Tribolube® Scuba Conditioner can be provided upon request.

RoHS Compliance

All products manufactured and distributed by Aerospace Lubricants, Inc. **conform** to the requirements outlined in European RoHS, RoHS2, and RoHS3 regulations (**Directives 2002/95/EU, 2011/65/EU, & 2015/863/EU, as amended**)

- No **mercury, cadmium, lead, hexavalent chromium, polybrominated biphenyls (PBB's), polybrominated diphenyl ethers (PBDE's), or restricted phthalates (DEHP, BBP, DBP, DIPB)** are intentionally added to any products.
- We do not expect these substances to be present in any of the raw materials that we use to manufacture these products. Any trace impurities of the restricted substances that may be present in the products are expected to be below the RoHS specified threshold levels.
