Generally, Boscodur® 4L (Part B) is blended into the adhesive or coating (Part A) at 2 - 10% and used as a batch within 4 to 6 hours of mixing. Refer to individual Bostik adhesive product data sheets, for mix ratio information. Add solvent thinner, when necessary, immediately after mixing the curing agent into adhesive.
