

- 1. For best performance bond surfaces should be clean and free from grease.
- 2. The product is designed to be initially cured by UV/visible light at a minimum irradiance of 70 mW/cm2 for approximately 60 seconds, increased exposure may be required for curing deeper sections.
- 3. Functional strength is achieved almost instantly.
- 4. Full performance properties will develop over 72 hours.
- 5. Excess material can be easily wiped away with non-polar solvents.
