The viscosity of this product makes the adhesive well suited for applications where the adhesive will be dispensed on the cannulae before assembly with the hub, needles with large gaps, or cannulae that end in the core pinbore to minimize the potential for blocking cannulae. LOCTITE® AA 3943™ achieves exceptional needle pull strengths on most hub substrates, particularly on high gauge sizes. Suitable for use in the assembly of disposable medical devices.




