# 4. FIRST AID MEASURES

# Description of first aid measures General advice:

# Advice for firefighters

**Fire Fighting Procedures:** Use water spray to cool unopened containers.. Evacuate area.. Collect contaminated fire extinguishing water separately. This must not be discharged into drains.. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations.. # **6. ACCIDENTAL RELEASE MEASURES**

# 7. HANDLING AND STORAGE
