**Octamethyl Cyclotetrasiloxane**

Results from a 2 year repeated vapour inhalation exposure study to rats of octamethylcyclotetrasiloxane (D4) indicate effects (benign uterine adenomas) in the uterus of female animals. This finding occurred at the highest exposure dose (700 ppm) only.

Studies to date have not demonstrated if these effects occur through pathways that are relevant to humans. Repeated exposure in rats to D4 resulted in protoporphyrin accumulation in the liver. Without knowledge of the specific mechanism leading to the protoporphyrin accumulation the relevance of this finding to humans is unknown.

Glycidoxypropyltrimethoxysilane was found to be genetically active in Ames reverse mutation assays, In Vitro sister chromatid exchange assays, and an In Vivo mouse micronucleus assay. This ingredient was not genetically active in an In Vivo cytogenetic assay (mice) or in an In Vivo sister chromatid exchange assay (rabbits, rats). The potential relevance of these data to humans is not known.
