SHELF LIFE

Shelf life is one year at 73°F (23°C) in sealed containers.

STORAGE & HANDLING

This resin will slowly absorb moisture from ambient air, which may cause foaming upon melting of the product. Therefore, care should be taken to minimize moisture exposure. Keep containers sealed when not in use and store in cool, dry area.

HM4231 is typically applied at temperatures between 375-425°F (191-218°C). Adhesive application is best conducted using conventional reservoir type hot melt applicators. These melter units can be equipped to apply adhesive via bead extrusion or swirl spray methods.
