4.1. Description of first aid measures

First-aid measures general

doctor if you feel unwell.

First-aid measures after skin contact

: Roll or peel skin apart if bonded. Wash skin with plenty of water. Take off contaminated

clothing. If skin irritation occurs: Get medical advice/attention.

First-aid measures after eye contact

: Immediately flush with plenty of water for at least 15 minutes. Get medical attention. If eyelids are bonded closed, release eyelashes with warm water by covering with a wet pad. Do not force eye open. Cyanoacrylate will bond to eye protein and will cause a lachrymatory effect which will help to debond the adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Medical attention should be sought in case solid particles of polymerized cyanoacrylate trapped behind the eyelid caused abrasive damage. Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye

irritation persists: Get medical advice/attention.

First-aid measures after ingestion

Adhesive becomes solid in contact with saliva and may adhere to inside of mouth. Saliva will lift adhesive in 1-2 days. Avoid swallowing solid adhesive after detachment. Call a poison center or a doctor if you feel unwell.
