## TYPICAL CURING PERFORMANCE

### **Recommended Drying Conditions**

5 to 10 minutes @ 25°C until it is dry to the touch

Care should be taken not to apply the mold release to surfaces assigned to be bonded later.

The above drying profile is a guideline recommendation. Conditions (time and temperature) may vary based on customers' experience and their application requirements, as well as customer drying equipment.

## Directions for Use

1. LOCTITE 122S RD E&C can be applied by brushing the mold release onto the mold with a soft brush or cloth. This will allow the user to apply the paste mold release selectively to only those

areas that require release properties.

- 2. A thin film of applied material is more effective than a thick film.
- 3. Thin layers of build up observed after a large number of applications of mold release material can be removed with the use of Hexane or chlorinated solvents.

### Storage

Store product in the unopened container in a dry location. Storage information may be indicated on the product container labeling.
